FACILITIES PRESENTLY AVAILABLE INCLUDE: A 300 METER RIFLE RANGE, 200 METER ALL-PURPOSE RANGE, 50 YARD OUTDOOR PISTOL RANGE, 50 FOOT INDOOR RANGE, MULTI-PURPOSE OUTDOOR RANGES, 5 TRAP FIELDS, 4 SKEET FIELDS AND A 40 YARD ARCHERY RANGE.

TO JOIN CJRPC:

- 1) **COMPLETELY FILL OUT** THIS APPLICATION AND BRING IT TO A NEW MEMBER ORIENTATION MEETING (6:30 PM START UNTIL APPROX 9:00 PM ENDING) HELD ON THE LAST WEDNESDAY OF EACH MONTH (NO DEC MEETING) AT THE CJRPC CLUBHOUSE.
- 2) **THE PURPOSE OF THE NEW MEMBER ORIENTATION** MEETING IS TO STRESS SAFETY AND FAMILIARIZE YOU WITH THE SCOPE AND REGULATIONS OF CJRPC AND ASCERTAIN IF YOU CAN FOLLOW DIRECTIONS FROM A RANGE OFFICER AND HANDLE FIREARMS SAFELY.
- 3) **FOR SAFETY REASONS** THE ORIENTATION BEGINS AND ENDS AS A GROUP. THEREFORE INCOMPLETE APPLICATIONS OR BEING LATE FOR THE ORIENTATION IS CAUSE TO BE RESCHEDULED UNTIL THE NEXT REGULARLY SCHEDULED NEW MEMBER MEETING.
- 4) **ITEMS TO BRING TO MEETING:** A VALID NJ FIREARMS ID CARD (FFID) (APPLICABLE TO ALL APPLICANTS / OBTAINABLE BY OUT OF STATE RESIDENTS & NJ RESIDENT), DRIVERS LICENCE PHOTO ID (SAME ADDRESS AS FFID MANDATORY), NRA MEMBERSHIP CARD (MANDATORY), A RIM FIRE PISTOL OR A RIMFIRE RIFLE WITH 10 ROUNDS OF RIM FIRE AMMO. IF A RIMFIRE FIREARM IS NOT AVAILABLE, YOU MAY BRING A CENTERFIRE PISTOL WITH 10 ROUNDS OF AMMO. DRESS APPROPRIATELY FOR ABOUT 15 MINUTES OF OUTDOOR SHOOTING. ALSO EYE AND EAR PROTECTION IS REQUIRED. A CHECK OR MONEY ORDER TO COVER YOUR ANNUAL DUES & CAPITAL CONTRIBUTION FEE AS DESCRIBED BELOW (**CASH NOT ACCEPTED**).
- 5) **FOLLOWING THE NEW MEMBER ORIENTATION** MEETING, YOU ARE REQUIRED TO ATTEND THE NEXT GENERAL MEMBERSHIP MEETING --HELD THE FIRST WED OF EACH MONTH-- AT WHICH TIME YOU'LL RECEIVE YOUR CJRPC MEMBERSHIP CREDENTIALS AND BE INTRODUCED TO THE CLUB'S MEMBERSHIP.

CAPITAL CONTRIBUTION FEE (A ONE TIME FEE) IS **\$600.00** (NON TAXABLE) AND IS EITHER PAYABLE IN FULL OR AS A **\$300** (NON TAXABLE) PARTIAL PAYMENT WITH BALANCE OF **\$320** REMAINDER PAID IN NO MORE THAN (4) EQUAL QUARTERLY **\$80.00** (INCLUDES **\$5.00** SERVICE CHARGE) INSTALLMENTS.

HONORABLY DISCHARGED SERVICE PERSONNEL WHO SUBMIT A COPY OF THEIR DD214 WILL RECEIVE \$100 DISCOUNT.

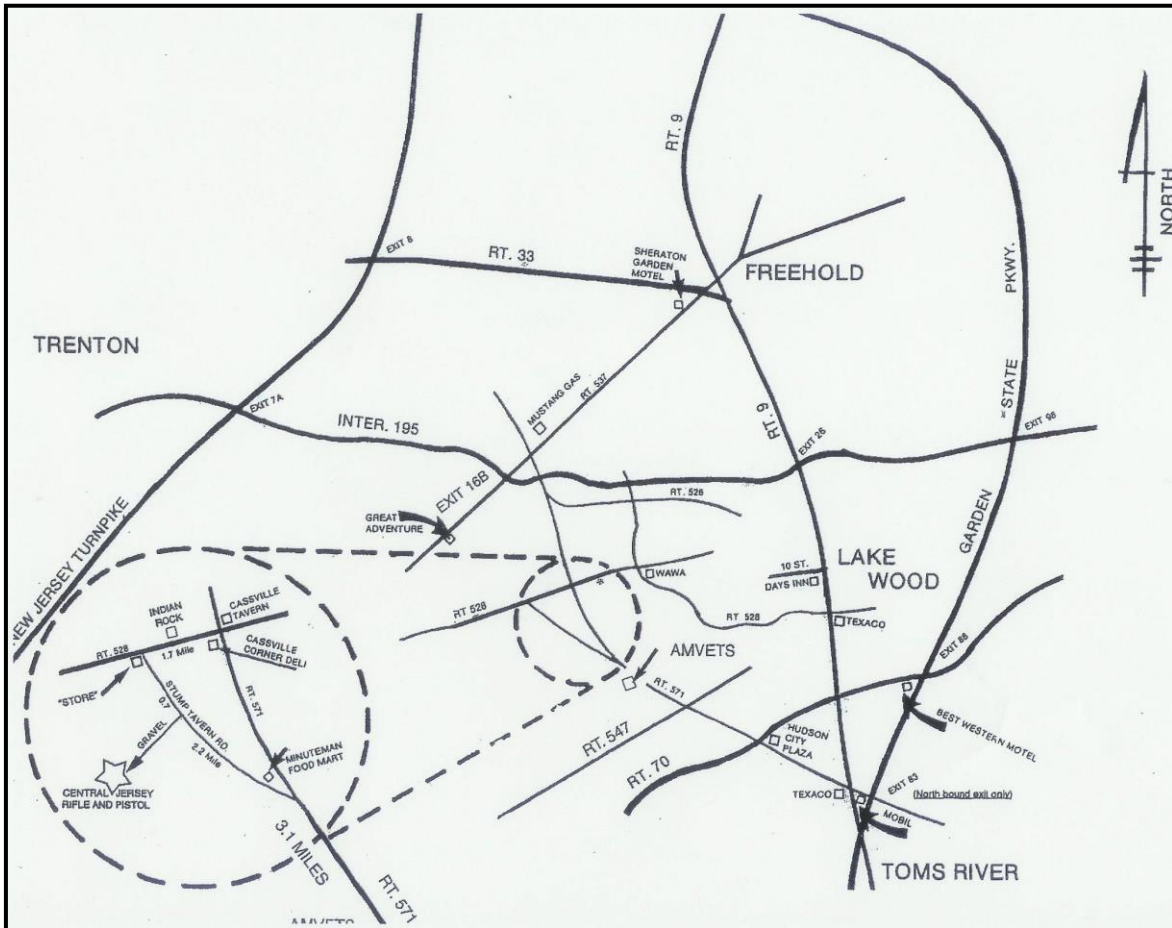

FROM NEW JERSEY TURNPIKE: NJ TURNPIKE TO EXIT 7A. TAKE I-195 EAST 10 MILES TO EXIT 16B ONTO RTE 537 EAST. GO THROUGH A FEW TRAFFIC LIGHTS TILL RTE 571 (GAS STATIONS ON CORNERS). MAKE RIGHT ONTO RTE 571. GO APPROX 4.5 MILES TO SECOND TRAFFIC LIGHT (CASSVILLE TAVERN ON LEFT CORNER). MAKE RIGHT ONTO RTE 528 (VETERANS HIGHWAY). GO 1.75 MILES AND MAKE LEFT ON STUMP TAVERN ROAD (A SHARP LEFT HAND TURN). GO APPROX 0.75 MILE AND MAKE RIGHT AT DRIVEWAY WITH YELLOW SIGN "CENTRAL JERSEY RIFLE & PISTOL CLUB."

FROM SOUTHBOUND GARDEN STATE PARKWAY: GET OFF GSP EXIT 123 (RTE 9 SOUTH). GO APPROX 10 MILES TILL YOU ARE NEAR TRAFFIC LIGHTS RIGHT BEFORE FREEHOLD RACEWAY AND RACEWAY PARK MALL. STAY IN RIGHT LANE AND LOOK FOR SIGN AND EXIT "W. BROADWAY, FREEHOLD." THEN EXIT UP THE RAMP TO TRAFFIC LIGHT. MAKE RIGHT ONTO RTE 537 WEST. GO APPROX 8.5 MILES TO A TRAFFIC LIGHT AT RTE 571 (GAS STATIONS ON CORNERS). MAKE LEFT ONTO RTE 571. GO APPROX 4.5 MILES TO SECOND TRAFFIC LIGHT (CASSVILLE TAVERN). MAKE RIGHT ONTO RTE 528 (VETERANS HIGHWAY). GO 1.75 MILES AND MAKE A LEFT ONTO STUMP TAVERN ROAD (A SHARP LEFT). GO APPROX 0.75 MILE AND MAKE RIGHT AT DRIVEWAY WITH YELLOW SIGN "CENTRAL JERSEY RIFLE & PISTOL CLUB."

FROM NORTHBOUND GARDEN STATE PARKWAY: GET OFF GSP EXIT 83 (ONTO RTE 9 NORTH). GO APPROX 1 MILE TO 1ST TRAFFIC LIGHT (TEXACO & MOBIL GAS STATIONS ON CORNERS). TURN LEFT ONTO RTE 571. GO APPROX 10 MILES TO STUMP TAVERN ROAD (A FOOD MART ON CORNER). TURN ON AN "ANGLED" LEFT ONTO STUMP TAVERN ROAD AND GO 2.2 MILES AND MAKE LEFT AT DRIVEWAY WITH YELLOW SIGN "CENTRAL JERSEY RIFLE & PISTOL CLUB."
